**SUBJECT:** ASYCUDA WORLD DECLARATION PROCESSING SYSTEM

---

ALL IMPORTERS, EXPORTERS AND CUSTOMS CLEARANCE AGENTS ARE HEREBY ADVISED THAT THE **ASYCUDA WORLD DECLARATION PROCESSING SYSTEM** WILL BE INTRODUCED FOR OPERATIONAL USE AT THE CUSTOMS HQ IN HONIARA ON **15<sup>TH</sup> JUNE 2015**.

TO COMPLEMENT THE INTRODUCTION OF THE NEW SYSTEM AN UPDATED CUSTOMS TARIFF (HS 2012) WILL ALSO BE INTRODUCED ON THAT DATE, TOGETHER WITH THE SINGLE ADMINISTRATIVE DOCUMENT (SAD) - WHICH WILL REPLACE VARIOUS DECLARATIONS CURRENTLY IN USE.

### **DECLARATION PROCESSING**

TO ASSIST IMPORTERS, EXPORTERS AND CUSTOMS CLEARANCE AGENTS IN THE COMPLETION AND PROCESSING OF THE SINGLE ADMINISTRATIVE DOCUMENT A SERIES OF 'HOW TO' NOTES ARE AVAILABLE ON THE ASYCUDA WEB SITE – [WWW.CUSTOMS.GOV.SB](http://WWW.CUSTOMS.GOV.SB)

IN ADDITION STAFF WILL BE AVAILABLE AT THE CUSTOMS BUSINESS CENTRE AT THE CUSTOMS HQ IN HONIARA TO ASSIST INDIVIDUALS IN THE COMPLETION OF THEIR DECLARATIONS.

IMPORTERS, EXPORTERS AND CUSTOMS CLEARANCE AGENTS SHOULD BE AWARE THAT FROM **MID-DAY ON 11<sup>TH</sup> JUNE 2015** NO FURTHER DECLARATIONS WILL BE ACCEPTED BY CUSTOMS FOR PROCESSING IN THE PC TRADE SYSTEM.

### **PAYMENTS**

TO FACILITATE THE PAYMENT OF DECLARATIONS PROCESSED IN PC TRADE THE AX SYSTEM WILL REMAIN OPERATIONAL AT THE CUSTOMS HQ IN HONIARA UNTIL **TUESDAY 30<sup>TH</sup> JUNE 2015**. AFTER THAT DATE ANY DECLARATIONS PROCESSED BY PC TRADE WILL BE CANCELLED AND IMPORTERS, EXPORTERS AND THEIR AGENTS WILL BE REQUIRED RESUBMIT THEIR DECLARATIONS USING THE ASYCUDA WORLD SYSTEM. IN THE EVENT THAT A DECLARATION HAS BEEN PARTIALLY PAID IT WILL BE NECESSARY FOR IMPORTERS, EXPORTERS AND AGENTS TO PAY ANY REMAINING BALANCE BEFORE 30<sup>TH</sup> JUNE.
