TO: ALL USERS OF THE ASYCUDA WORLD SYSTEM

SUBJECT: MINIMUM CONFIGURATION REQUIREMENTS

AS YOU WILL BE AWARE THE ASYCUDA WORLD AUTOMATED SYSTEM WAS INTRODUCED FOR OPERATIONAL USE ON MONDAY 15TH JUNE 2015.

A MAJOR BENEFIT OF THE ASYCUDA WORLD SYSTEM IS THE OPPORTUNITY IT PROVIDES IMPORTERS, EXPORTERS AND OTHER USERS OF THE SYSTEM TO INPUT THE DETAILS OF THEIR DECLARATIONS DIRECTLY INTO THE WEB BASED SYSTEM USING THEIR OWN COMPUTERS FOR SUBSEQUENT PROCESSING BY CUSTOMS.

IN ORDER TO DO SO ALL USERS OF THE SYSTEM SHOULD ACCESS THE SYSTEM VIA THE ASYCUDA WEB PORTAL – www.customs.gov.sb. TO FACILITATE THIS PROCESS YOU SHOULD BE AWARE THAT THE MINIMUM CONFIGURATION REQUIRED FOR ACCESSING THE AW SYSTEM IS:

- 4GB RAM
- WINDOWS OS (64 BIT PREFERABLE)
- 2.6/3.0 GHZ CLOCK SPEED
- HD 320 GB
- ADOBE ACROBAT READER
- JAVA RUNTIME 1.0.6_17
- 512 KPBS INTERNET CONNECTION (ADSI PREFERABLE)

FOR THOSE IMPORTERS, EXPORTERS AND OTHER USERS OF THE SYSTEM WHO DO NOT HAVE ACCESS TO A COMPUTER, LIMITED FACILITIES ARE AVAILABLE AT THE **CUSTOMS BUSINESS** CENTRE AT THE CUSTOMS HQ OFFICE IN HONIARA TO ENABLE THEM TO INPUT THE DECLARATION DATA INTO THE SYSTEM.

TO FURTHER ASSIST YOU IN PROCESSING YOUR DECLARATIONS, OFFICERS WILL BE PRESENT AT THE CUSTOMS HQ - AND A SERIES OF 'HOW TO NOTES' ARE AVAILABLE ON THE ASYCUDA WEB SITE. YOU CAN ALSO CONTACT US BY E-MAIL ON: awhelpdesk@customs.gov.sb.
